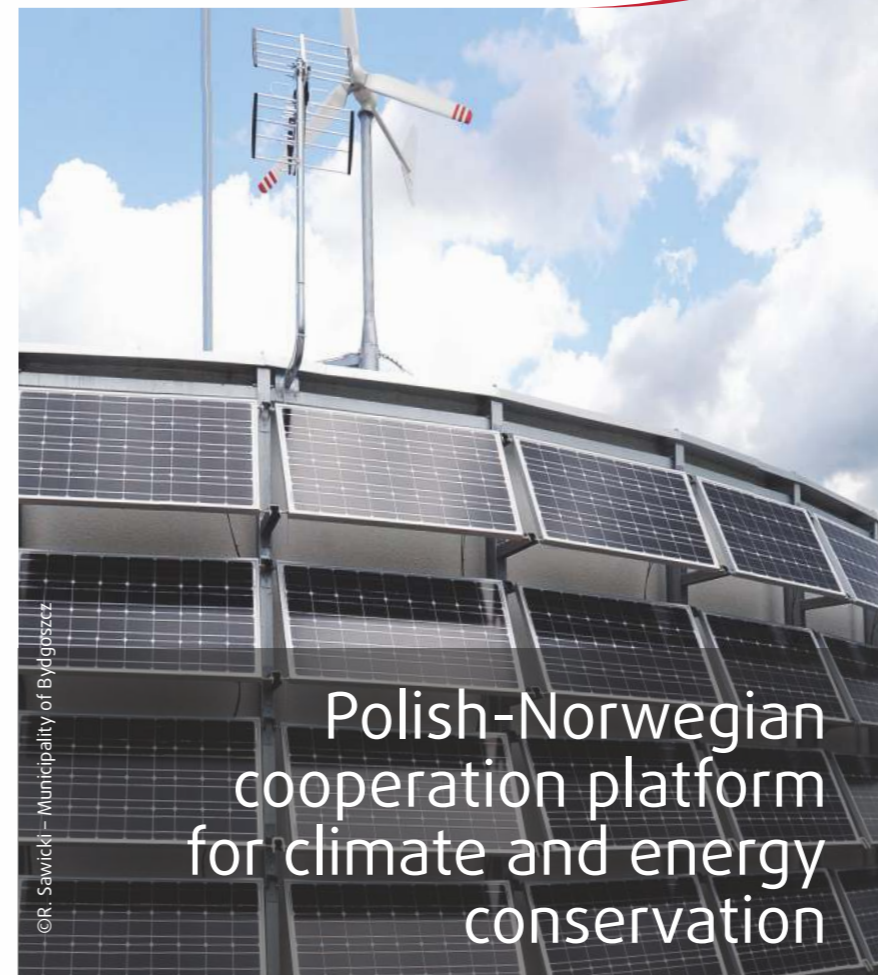

ABOUT THE PROJECT

The aim of the project "**Polish-Norwegian cooperation platform for climate and energy conservation**" is to establish and strengthen bilateral cooperation between Norwegian and Polish municipalities, covering the exchange of experience, knowledge, technologies and best practices in the area of energy efficiency (EE) and the use of renewable energy sources (RES) in the municipal sector.

Implementation of the project is divided into three phases:

- 🔦 **Diagnostic phase:** analysis of the current situation and best practices in the field of EE and RES use in Poland and Norway, as well as creating mechanisms facilitating efficient dialogue and exchange of experience between entities from both countries.
- 🔦 **Open contest phase:** organisation of the open contest for the best ideas for innovative energy projects inspired by Norwegian experience and prepared by Polish municipalities.
- 🔦 **Implementation phase:** implementation of the 10 winning projects with the support of the Norwegian partners.

Duration: January 2016 - April 2017



ACTIVITIES

Establishment of the Polish-Norwegian Cooperation Platform, which provides space and opportunities for efficient dialogue and exchange of experience between Polish and Norwegian municipalities and their partners.

Development of the diagnosis of the situation of Polish and Norwegian municipalities in terms of energy efficiency and RES use, which answers the questions about their current energy planning & management processes, as well as helps to identify the most important barriers, challenges and needs.

Development of the catalogue of best practices in the area of energy efficiency and RES use, including examples of inspiring investments and actions implemented by both Polish and Norwegian municipalities.

Organisation of a series of meetings of the Experience Exchange Group, which gathers municipalities and aims at analysing current and developing new, innovative solutions in the area of EE and RES use.

Organisation of the open contest for the best ideas for innovative energy projects inspired by Norwegian experience. 10 winning projects will be awarded with micro-grants for the preparation of necessary analyses and documentation.

Organisation of the study visit in Norway, during which representatives of the winning municipalities will have an opportunity to get acquainted with the most interesting Norwegian investments and energy strategies implemented on the national, regional and local level.

Implementation of 10 pilot projects in cooperation with experienced Norwegian municipalities, who will support Polish local authorities in working out the details and implementation of their ideas. Signed Memorandums of Cooperation will be also a basis for future joint initiatives!

 - 3 meetings of the Experience Exchange Group
 - 2 bilateral conferences
 - a series of thematic webinars
- 🔦 publication of documents summarising and disseminating results of the project, including:
 - diagnostic report on the energy situation of Polish and Norwegian municipalities
 - catalogue of best practices in the area of EE and RES use
 - final publication

Their experience may be valuable for Polish municipalities, therefore this project aims at creating conditions for the efficient and regular exchange of experience, knowledge, ideas and best practices, which will result in successful implementation of local climate & energy targets.
